P.S. Concerning the source "A History of Barrington Township and Vicinity 1604-1870" by Edwin Crowell, the Thomas & Nicholas he mentions coming from England, seems to be incorrect. Nicholas was the son of Henry GOODWIN and Eliza WEYMOUTH mentioned in the direct line, and Thomas was the grandson of Henry through his son Palatiah. I have heard from a person who has done a great deal of research, that there were several mistakes in Rev. Crowell's material.

Jedidah, father of Daniel, had 8 children by his first wife and 9 by his 2nd wife.

WIGWAM

The word *WIGWAM* doesn't necessarily imply an Indian cabin. It was a name often given by the early pioneers to a logging shanty in the forest. Mention is made of one of these 21 Nov. 1706, when land was laid out to Thomas GOODWIN in Kittery, near the Salmon Falls River, above the "Nine Notches" beginning about 30 or 40 poles below the logging house or wigwam that Wm. GRANT, Thomas and Daniel GOODWIN, and Joseph HOD80N slept in the last winter. (Kittery Records Historical Magazine Oct. 1868 P. 192) P. 99 Collection of Dover. N.H. Historical Society.

On p. 156 of above book the word Newiehawannock is derived from Indian (ne-week-won-auk) meaning "my wigwam place", and was the name of an Indian village above the Salmon Falls River. It was given to the river going to Piscata - and above head of the water of the Salmon Falls River, New Hampshire.

THE GOODWIN FAMILIES OF NEWPORT, N. H., AND THEIR RELATIONSHIP

By CHARLES A. GOODWIN-PERKINS, of Hoopston, Ill

The Goodwin families of Newport, N. H., were descended from Samuel and Richard Goodwin of Amesbury, Mass., sons of Richard and Mary (Fowler) Goodwin and grandsons of Edward Goodwin, the immigrant, who first located in Newbury, Mass., then, after 1608, operated the ferry over the Merrimac River between that town and the new settlement of Amesbury, Mass. (Joseph Merrill, History of Amesbury, 1880, p. 92; John J. Currier, History of Newbury, Mass., 1902, p. 439; David W. How. The Old Families of Salisbury and Amesbury, 1897, vol. 1, p. 173).

1. SAMUEL³ GOODWIN (*Richard², Edward¹*), shipbuilder, of Amesbury, Mass., married there, 24 Dec. 1701, ESTHER JAMESON, daughter of John and Esther (Martin) Jameson and granddaughter of James Jameson. Esther Martin was a daughter of George and Susanna (North) Martin (the latter was the Susanna of Whittier's poem "The Witch's Daughter" (cf. Charles W. Upham, Salem Witchcraft, 1867, vol. 2, pp. 145-149; Hoyt, *op. cit.*, vol. 2, p. 752).
